1 Introduction

1.1 The most up to date information on all projects is incorporated in this report.

2 Reserve Fund Programme Areas

2.1 Dock Symbister – RCM 2309

The project was delayed to financial year 2005/6. Currently awaiting costs from Henderson's and final approval from Historic Scotland.

3 Harbour Account

- 3.1 <u>Plant, Vehicles and Equipment PCM 2101</u> New vehicles purchased. Budget will be fully utilised this year.
- 3.2 Navigational Aids, Sullom Voe PCM 2104
 - 3.2.1 AIS system in Scalloway now fitted with updated charts
 - 3.2.2 Five contractors were invited to bid for the VHF/ Communications upgrade for VTS Sullom Voe. Only one bid was received and this is presently being evaluated. A verbal update will be given to the Harbour Board at this meeting. All the remaining resources in the Nav-Aids budget will be fully utilised.

5.3 West Burrafirth

New bunded fuel system to be fitted by LHD once Papa Stour Ferry commences operating from the new ferry pier.

5.4 Mid Yell

LHD have applied for permission to build bunded fuel tank on Mid Yell pier. Provisional permission granted.

5.5 Small Ports Marketing Group

AB Associates are completing the final draft of their report. There will be a meeting in Scalloway at the end of the month to discuss the contents and recommendations.

1 Introduction

1.1 This report provides an overview of port operations since the issue of the last Port Operations Report.

2 Pilotage

- 2.1 <u>Sullom Voe</u>
 - 2.1.1 Since the issue of the last Port Operations Report, pilotage operations have been mainly routine with no major incidents.
 - 2.1.2 There are, at present, fifteen first class pilots.
- 2.2 Scalloway
- 2.2.1 During July / August there were 6 acts of Pilotage.
- 2.2.2 There are three authorised pilots for Scalloway.
 - 2.2.3 Since the last report, there have been no incidents, no reports of pilot gear failures and no problems with boarding and landing.
 - 2.2.4 Details of ship visits to Scalloway are shown in Appendix A. Up to date figures will be provided to the next meeting.

5 Shipping Standards

The following incidents have occurred since the last report.

- 5.1 Ship Incidents
 - 5.1.1 There were no incidents during this period..
- 5.2 Pollution Incidents
 - 5.2.1 On 9 August 2005 the British registered tanker, Loch Rannoch, spilled five litres of diesel whilst alongside at Jetty 4 as the result of an incomplete burn at the start-up of the ship's Inert Gas system. Light sheens were dispersed by a pilot launch.
 - 5.2.2 At approx. 2145 hrs on Saturday, 3rd September 2004 the

Emergency Response Vessel "Anglian Sovereign" ran around on the Cheynies north of Oxna on the west side. All but 2 crew were evacuated by the Coastguard helicopter Oscar Charlie leaving the Master and one other crew member.

The vessel refloated herself and proceed via the south entrance into Scalloway harbour where she berthed at 0015 Sunday, 4th September. The vessel was releasing marine diesel oil from three ruptured fuel tanks both through the bottom and also from the tank air vents.

The vessel was met by the Council's harbour and pollution response staff plus a counter pollution team from the Sullom Voe Oil Terminal. Booms were deployed around the vessel to contain the oil. Oil recovery operations were commenced and continued over the next 5 days employing vacuum trucks, rope mop skimmers, DLO labour and plant to recover oiled beach materials and a wild life team to recover oiled birds and survey birds in the general area of Oxna and the harbour area.

The ship lost a total of 84 cubic meters of oil into the environment which was not recovered. A further 185 cubic meters were taken from the ships damaged tanks or collected by the skimmers and vacuum trucks.

The Master faces a total of 5 charges from the Police, Marine and Coastguard Agency and SEPA. He will appear in Court in due course.

The cleanup operation went smoothly and, through daily Management Team meetings at Scalloway Harbour Office, all parties were kept fully informed of the situation. In additional to Council staff recognition for a good job well done regarding recovery operations should be given to the following. BP Exploration and Production Sullom Voe, Total Waste Management, SBS Logistics and A Goodlad and crew of the "Reflex." Other members of the Management Team included, SEPA, SIC Environmental Heath, Ports and Harbours Operations, Shetland Aquaculture, Seafood Shetland, Shetlans Fisherman's Association, Marine and Coastguard Agency, International Tanker Owners Pollution Federation plus wildlife recovery/surveys by Martin Heubeck and Peter Ellis of the RSPB.
