## 02/14 Harbourmaster's Report

### Navigational Risk Assessment (NRA)/SMS review

The new Manuals are to be submitted for formal approval, and following which, will be signed off by the Chair of the Harbour Board and the Council's Chief Executive before the end of January 2014.

#### Designated Person

In reporting on the 4 instances in December when the VTS was not fully operational, Members were advised that these breaks in operation had been due to a combination of reasons.

In response to a question, the Harbour Master advised the Board on the circumstances of the near miss incident involving the pipe laying vessel "Calamity Jane", which is being reported to the Examination Panel. A Member made comment that Members of the Harbour Board had not received information in regard to the incident.
