**Licensing (Scotland) Act 2005 – Revocation of Personal Licences**

1. Introduction

- 1.1 This report asks the Board to consider the information below and to revoke each of the Personal Licences noted in the Appendix. Revocation of the licences is the only course of action open to the Board.
- 1.2 This report also asks the Board to consider delegating authority to revoke personal licences to the Clerk where the licence holder has failed to comply with refresher training requirements.

2. Background

- 2.1 In accordance with section 71 of the Licensing (Scotland) Act 2005 (“the Act”) a Personal Licence may be issued by the Board authorising the individual to supervise or authorise the sale of alcohol. A personal licence has effect during the period of 10 years from the date on which it is issued.
- 2.2 The holder of a Personal Licence is required to undertake training and to provide to the Board evidence of having done so: section 87. Such evidence must be produced to the Board no later than three months after the expiry of five years from the date on which the Personal Licence was issued, and each subsequent five year period.
- 2.3 The Board must give notice to the holder of a Personal Licence of the requirement to undertake training, no later than three months before the expiry of each five year period.
- 2.4 If a Personal Licence holder fails to comply with the training requirements and fails to provide evidence of training to the Board within the statutory time, the Board must revoke the licence: section 87(3). If the Board revokes a Personal Licence the individual cannot apply for a new Personal Licence for a period of five years: section 74(3)(c).

3. Notifications to Personal Licence holders

- 3.1 The Board has given notice to each of the personal licence holders noted in the Appendix to this report, of the requirement to undertake training. They have each failed to produce evidence of having complied with training within the statutory time.

#### 4. Summary

- 4.1 The Board has complied with the requirement to give notice to personal licence holders of their statutory training obligations. Each of the personal licence holders noted in the Appendix to this report having failed to comply with their statutory duty, the Board has no alternative but to revoke each of those personal licences.
- 4.2 As noted in 4.1 above the Board has no alternative but to revoke a personal licence in the circumstances described. The Board is therefore asked to consider if it wishes to delegate authority to the Clerk to revoke personal licences in such circumstances. Delegating this function would be administratively more efficient and more cost effective.

#### 5. Recommendations

- 5.1 I recommend that the Board notes the content of this report and determines to revoke the personal licences held by those in the Appendix to this report.
- 5.2 I recommend that the Board delegate authority to the Clerk to revoke a personal licence where the holder has failed to comply with the section 87 training requirements.
