(a) Monterey Jacks Lerwick Ltd	Monterey Jacks 88 Commercial Street Lerwick Shetland ZE1 0EX	To amend access for children and young persons to allow unaccompanied access under certain conditions, as noted below:- Children and Young Persons will be permitted access. Children will require to be accompanied by an adult after 8.00pm and Young Persons accompanied by an adult after 10.00pm. Children and Young Persons will require to vacate the premises by Midnight. Prior to these times, at Management discretion, Children and Young Persons will be permitted access for the purpose of consumption of food and non-alcoholic beverages.

LSO comments:

I have no objections to the proposal but have the following comment to make:

The proposed variation is to change the times when children and young persons can have access to the premises as follows:

- Children to be accompanied by an adult after 8pm
- Young Persons to be accompanied by an adult after 10pm and
- All Children and Young Persons require to vacate by Midnight

All of the above will take careful supervision as there are three different time periods to manage two different age groups.

Gambling Act 2005
Three Year Policy Statement – 2016/19**

1. Introduction

- 1.1 The purpose of this report is to finalise the Three Year Policy Statement under the Gambling Act.

2. Background

- 2.1 In terms of the Gambling Act 2005, Section 349, the Board is required to publish every three years a statement of the principles that they will propose to apply in exercising their functions under the Gambling Act 2005. The statement of principles has to conform to the terms of the Gambling Act 2005 (Licensing Authority Policy Statement) (Scotland) Regulations 2006.
- 2.2 The Board considered a draft Policy Statement at their meeting on 5 June 2017. The Board then published the Statement in accordance with the Regulations and sought comments.
- 2.3 The draft Policy Statement can be viewed online at http://www.shetland.gov.uk/about_introduction/documents/PolicyStatementofGamblingLicensingPrinciples2016-2019-Draft.pdf
- 2.4 The consultation period ended on 7 August 2017. No comments were received from any of the consultees or from the public.
