

## Application Form for the Registration of a Food Business Establishment (Fishing Vessel)

E.C. Regulation 852/2004 - Article 6 (2)

This form **must** be completed by the food business operator or his/her representative/agent in respect of a fishing vessel. Any person who in, or in connection with, the making of this application makes any statement which they know to be false shall be guilty of an offence and liable on conviction to a fine or imprisonment.

Based on the type of activities carried out, certain fishing vessels are required to be **approved** rather than **registered**. If you are unsure whether any aspect of your food operations would require your establishment to be approved, please contact Shetland Islands Council Environmental Health Service for guidance.
