Francesca MacColl N920 Lerwick Police station attended the meeting and updated the Committee on how officers have been engaging with the community and gave a summary of some of the reported incidents giving an indication of ongoing police activity in Lerwick.

There have been three hundred and thirty incidents recorded for the Lerwick area.

A summary of the incidents of note can be broken down to the following categories

- 1. Noise Neighbour 15
- 2. Drink Driving 2
- 3. Assaults 3. (1 in a licensed premise)
- 4. Breach of the Peace/Disorder 5
- 5. Vandalisms 16
- 6. 5 people searched and found in possession of drugs
- 7. Theft –2.
- 8. Anti-social behaviour Fixed Penalties tickets 1

The remainder of the calls and incidents have been of a routine nature. There have also been a number of road traffic offences detected in and around Lerwick which have included 17 drivers charged with driving without an MOT, 2 drivers charged with driving without insurance, 10 drivers charged with speeding offences and 1 driver charged with a seatbelt offence.

Again, multiple drugs packages were intercepted at Lerwick Post Office sorting depot; and this still appears to be a popular way of sourcing drugs locally.

DR asked about checks on the route from the town centre to Norscot and the police noted this and will try to undertake more patrols.
