Applications for Funding- Community Development Fund

Applications for funding- Shetland Community Benefit Fund

South Nesting Boating Club have applied for £20,178 towards a bird and otter survey and various fees. Mr K Bradley attended and spoke to members about this application. He then left the meeting, Community Council members unanimously agreed to grant the £20,718.
